YOUR SUPPORT IN THIS MOVEMENT IS MOTIVATING AND WILL ENCOURAGE OTHERS IN THIS FIGHT FOR FREEDOM AND JUSTICE. WE APPRECIATE THE WORK YOU ALL ARE DOING

OUR FAMILY AND SUPPORTERS FROM AROUND THE WORLD CONTINUE TO WORK FOR OUR RELEASE THEY ARE PUTTING PRESSURE ON THESE OFFICIALS AND THE PAROLE BOARD WHO IS CONTINUING THE CONSPIRACY TO KEEP MOVE IN PRISON BY GIVING US HIT AFTER HIT FOR NO JUSTIFIED REASON. THIS GOVERNMENT KNOWS ~~TO~~ MOVE IS INNOCENT. THESE OFFICIALS DARE TO CALL MOVE MEMBERS MURDERERS BASED ON THE FALSE ACCUSATIONS OF THE MURDER OF ONE COP WHILE 11 MOVE MEN, WOMEN, BABIES AND NUMEROUS ANIMALS WERE MURDERED ON ORDERS FROM GOV'T OFFICIALS BUT NONE OF THEM HAVE BEEN CHARGED WITH THE MURDER OF OUR FAMILY MEMBERS. WE ARE SERVING 30-100 YEARS IN PRISON DESPITE OUR INNOCENCE AND THOSE OFFICIALS ARE COLLECTING PENSIONS DESPITE THEIR GUILT.

DENIED 3 TIMES BECAUSE WE WONT LIE AND  
SAY WE ARE GUILTY WHEN IN FACT WE ARE  
INNOCENT AND HAVE MAINTAINED THAT POSITION  
FROM DAY ONE. WE ENCOURAGE PEOPLE TO  
SUPPORT OUR FAMILY, JOIN THEM IN KEEPING PRESSURE  
ON THE PAROLE BOARD AND THESE OFFICIALS, DONT  
LET UP, KEEP THOSE LETTERS AND CALLS COMING
